NOTICE TO THE PUBLIC

Generally, the President will ask Board Members for the remarks prior to recognizing requests to speak from the audience. Closed Sessions may convene before, after or during the Regular Meeting. Closed Session items may include personnel, litigation, and negotiations and/or students discipline.
