NOTICE TO THE PUBLIC

As agenda items are discussed by the Board during the Open Session of the Board Meeting, audience participation is permitted. The President will recognize those members of the audience who wish to speak.

The President will set a time limit on each person's remarks if he/she feels it necessary. Individual speakers shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. With Board consent, the president may increase or decrease the time allowed for individual comments. The Board shall limit the total time for public input on each item to twenty (20) minutes. With Board consent, the president may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The president may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add. Generally, the President will ask Board Members for the remarks prior to recognizing requests to speak from the audience. At the President's discretion, agenda items may be considered in an order other than numerical order.

Closed Sessions may convene before, after or during the Meeting. Closed Session items may include personnel, litigation, and negotiations and/or student's discipline.

A. <u>Approve adoption of My World History Social Science Curriculum for Grade K-1.</u> (Justin Kern)

(BACKGROUND: Schools are required to provide instruction in all core subjects to students in grades TK-12 use board-approved curriculum. Pearson-Savvas My World was adopted in spring of 2022 for grades 2-5, and the staff recommend approval of the Pearson-Savvas My World curriculum for grades K-1 as well.)

B. Approve adoption of Inspire Science Curriculum for Grades K-1 (Justin Kern)

(BACKGROUND: Schools are required to provide instruction in all core subjects to students in grades TK-12 use board-approved curriculum. McGraw-Hill Inspire Science was adopted in spring of 2022 for grades 2-5, and the staff recommend approval of the McGraw-Hill Inspire Science curriculum for grades K-1 as well.

C. <u>Approve adoption of Three Cheers comprehensive TK curriculum for piloting purposes</u> (Justin Kern)

(BACKGROUND: Schools are required to provide instruction in all core subjects to students in grades TK-12 use board-approved curriculum. Benchmark Three Cheers was selected by McKinley staff for piloting purposes in the 2023-24 school year as they seek to come into compliance with this requirement.)

D. <u>Approve Modifications to contract with Superintendent, Justin Kern, beginning</u> 7/1/2023 to increase health and welfare district contribution. (Heather Naylor)

(BACKGROUND: The certificated management included a negotiated increase in the health and welfare contribution to \$9,240. The superintendent contract includes language that the contribution will be the same. The district will increase the superintendent health and welfare by \$1,770 for an annual contribution of \$9,240)

E. <u>Approve Ag Incentive Grant for the Agriculture and Natural Resource Industry sector</u> (Rikki-Lee Burresch)

(BACKGROUND: The Ag Incentive Grant is an annual grant opportunity that must be applied for based on specific department criteria. Our program opens doors to students of every demographic group, whether low socioeconomic or special education our program offers an opportunity to learn meaningful skills which allows students to directly contribute to our community. These funds enhance the student experience.)

F. Approve Board Resolution # 01-2324 – Authorization to Teach Under Education Code 44256 (b) (Julie Vang)

(BACKGROUND:Each year districts are required to certify that their teachers are teaching in their credential area. One mechanism for a district to authorize a teacher to teach a subject other than the subject specified on their credential is by Ed Code authorization. Ed Code specifies what a teacher must do to qualify to teach outside the area of their credential. The teacher listed on this resolution have coursework in the subject areas they are teaching but are not authorized on their current credential to teach these subjects in a departmentalized classroom. The coursework they have in this area allows them to teach these classes under Education Code 44256(b).)

G. Approve Board Resolution # 02-2324 – Authorization to Teach Under Education Code 44258.3 (Julie Vang)

(BACKGROUND: California has many provisions within the Education Code that provide avenues for the assignment of certificated employees outside their basic credential authorization. These Education Code options provide school districts with local level flexibility for staffing.)

H. Approve Board Resolution # 03-2324 – Authorization to Teacher Under Education Code 44263 (Julie Vang)

(BACKGROUND: Each year districts are required to certify that their teachers are teaching in their credential area. One mechanism for a district to authorize a teacher to teach a subject other than the subject specified on their credential is by Ed Code authorization. Ed Code specifies what a teacher must do to qualify to teach outside the area of their credential. The teacher listed on this resolution have coursework in the subject areas they are teaching but are not authorized on their current credential to teach these subjects in a departmentalized classroom. The coursework they have in this area allows them to teach these classes under Education Code 44263.)

I. Approve Annual Statement of Need for Emergency 30-Day Substitute Permits (Julie Vang)

(BACKGROUND: The Annual Statement of Need must be filed at the school district office each year when employing holders of Emergency 30-Day Substitute Permits. It indicates that either no credentialed person is available or that those available are not deemed qualified for substitute teaching.)

J. Approve Declaration of Need for Fully Qualified Educators (Julie Vang)

(BACKGROUND: The Declaration of Need (CL-500) is the annual form submitted to the Commission on Teacher Credentialing (CTC) by school districts that contains the employing agency's estimated number of Emergency Permits, Limit Assignment Permits and Internships that will be requested during the school year. In order to employ Interns and Permit holders districts must have a CL-500 on file with the CTC.)

K. Approve updated Classified job descriptions with salary range changes (Julie Vang)

(BACKGROUND: The District and CSEA approved the Tentative Agreement (TA) Between CSEA and GUSD for 2023-24 School with language stating the current Classified Job Descriptions as identified in the Salary Schedule will be updated to the appropriate ranges. All classified job descriptions have been updated with the approved ranges per the TA.)
